The impacts arising from the covid-19 pandemic have affected all aspects, including legal, social, educational, etc. Like online schools, children often use cell phones to teach and understand that cell phones used to use social media should be intelligent and wise. This study uses sociological juridical research methods by going directly to the field to determine the actual conditions. This study indicates that mothers have difficulty understanding the importance of being intelligent and wise in using social media because if they are not wise and intelligent, it can cause new problems, not only social problems but also legal problems. The government has issued Law concerning Electronic Information and Transactions. It regulates various things to protect against the misuse of electronic information flows.

A. INTRODUCTION

In the sociological context, the family is considered to carry the key to success in the future which is an important role. Meanwhile, during this pandemic, social media is increasingly playing a role as a social media where physical gatherings are limited. Even though the characteristics of this new technology have an addictive effect on its users and will affect the behavior of children and adolescents, For example, in the real world, a teenager can be anti-social, quiet and doesn't talk much, but is very active on social media.

According to Purnama, other characteristics of social media include: 1) Reach: the reach of social media from a small scale to a global audience. 2) Accessibility: social media is more accessible to the public at an affordable cost. 3) Usability: social media is relatively easy to use because it does not require special skills and training. 4) Actuality (immediacy): social media can provoke a faster audience response. 5) Permanent (permanence): social media can replace comments instantly or easily carry out the editing process.⁴

Meanwhile, according to Badri, there are currently seven types of social media but innovation and change continue to occur. Social media that exist today are social networks such as Facebook, MySpace and Bebo. This site allows people to help personal web pages and connect with their friends

by sharing them through releases. If they like a product they don't hesitate to write about it on the internet.⁵

The addictive impact of using social media also has other effects, namely anxiety, difficulty sleeping and other disorders that arise when apart, known as Nomophobia.

The exposure on the background shows that it is important to use social media intelligently, especially at the developmental age of children and adolescents. Children's intelligence in utilizing social media is not necessarily present, but requires assistance from parents, where the figure of a mother plays a very important role.⁶

The mother is the initial milestone in determining the family, the family is the core of human life. Mothers are at the forefront during this pandemic to protect their families from exposure to the Covid-19 virus and the negative effects of exposure to social media. Lack of supervision can cause children to freely access things that are not good. In addition, the use of gadgets that are not wise can be subject to criminal sanctions.

This community service activity provides an opportunity for higher education institutions as service institutions to address the problems faced by the people in Banyumanik Village and their children as users of social media, and build communication through scientific articles, and in later stages by making universities as scientific resource persons to help solve various problems encountered related to science, technology and its applications.

The targets to be achieved through this service activity include, firstly, increasing skills and knowledge in social media and other transactions related to Information and Electronic Transactions, so that the development of information technology can be used optimally and appropriately. Second, provide assistance in developing the proper use of social media to increase awareness of the risks that will be obtained if social media is misused. Third, holding training related to the use of social media to be used intelligently and wisely.

B. RESEARCH METHODS

This service program uses a participatory approach. Partners are involved in identifying problems related to the use of mobile devices. In the early stages, fifteen Activator Family Welfare Development cadres in the Banyumanik sub-district were selected purposively to conduct a focused group discussion. The results of the ocused group discussion became the basis for preparing mentoring materials for Family Welfare Development cadres and building a support system for this program. From the results of the ocused group discussion, it was agreed that the implementation of this mentoring program would be carried out in several stages, namely: First, mapping and problem identification. Second, program socialization to

Activator Family Welfare Development members and community leaders. Third, Activator Family Welfare Development cadre training. Fourth Reflection, evaluate and develop an action plan.

C. RESULTS AND DISCUSSION

Women are targeted in this activity, because women are very close to education and childcare. The Family Welfare Development organization itself was chosen because it is the largest women's organization in Indonesia with an organizational structure that reaches down to the Neighborhood Association area.

The stages of mapping and identifying problems raised several things that were of concern to the community service team. The first is related to parents' understanding of the characteristics of internet technology and social media. This misunderstanding leads to neglect negative effects of this technology. Second, lack of understanding of the legal aspects of using social media. That there are legal implications for every upload and comment on social media, Family Welfare Development cadres do not fully understand. Third, the use of social media causes children to depend on devices.

Parents often take shortcuts by giving their children gadgets so that the parents' activities are not disturbed, or when the child is "fussy". These shortcuts, which are often not realized, are actually the justification for children to play gadgets and explore cyberspace.

During the Covid-19 pandemic, children also have strong reasons where learning materials and learning itself are mediated through devices connected to the internet. For teenagers, social media is often used as a medium to show existence and identity. They start showing what they like and don't like and even start showing what they are thinking or doing, showing or posting what they have or achieve.⁷

Excessive dislike is sometimes also simply uploaded via social media. They do not realize that every action in cyberspace also has legal implications as in the real world. In addition, cyber-based crimes also stalk them if they are not smart in social media.

Providing understanding and understanding for children is very important, adjusted to the age of the child. Providing an understanding that the importance of using social media is nothing but an effort to prevent and provide protection from crime. Cybercrime is a threat to children today.

However, social media cannot only be seen from a negative perspective, during this pandemic social media. The service team and partners also identify the positive impacts of social media so that their use will be more optimal. From the results of the focused group discussion, social media has become a fast communication channel for parents and teachers. Social media is also a medium for sharing fun learning content.

In addition, social media currently arises as a result of misuse of social media in disseminating information for users who enter the realm of law as a result of disseminating information on social media that does not use ethics. Internet World Stats states that Indonesia is a country with the sixth largest number of internet users worldwide. 10

Social media crimes through electronic or virtual are also increasing. This virtual crime is called cybercrime. This crime is irresponsible people through computer networks. Therefore, protection is needed and efforts can be made to overcome it. We can start by looking at aspects of criminal law, namely criminal formulation policies and aspects of criminal responsibility,

including socialization efforts to the public to be smart and wise in using the mass media.¹¹

The concept of legal protection for children from cybercrime in Indonesia, which is a country based on law, is in accordance with the provisions of the Convention on the Rights of the Child which has been ratified by the Government of Indonesia through Presidential Decree Number 36 of 1990 and then set forth in Law Law Number 4 of 1979 concerning Child Welfare. In addition, Law Number 23 of 2002 concerning Child Protection which was amended by Law Number 35 of 2014 concerning Amendments to Law Number 23 of 2002 concerning Child Protection, and Law Number 11 of 2012 concerning the Juvenile Criminal Justice System. All of them provide general principles in child protection, namely non-discrimination, the best interests of the child, the survival and development of the child.

In Indonesia it is also regulated in Law Number 11 of 2008 concerning Information and Electronic Transactions as the initial milestone in the development of information technology law in Indonesia. However, its presence has not answered the existing problems. This is fundamental because the dynamics of the development of information technology are developing quite rapidly so that Law Number 11 of 2008 has been conducted a judicial review in the Constitutional Court. Therefore, as the government's response to the development of information technology, Law Number 11 of 2008 in its development was amended by Law Number 19 of 2016 concerning Amendments to Law Number 11 of 2008. The ratification of the ITE law was due to legal aspects carried out by legal subjects who take advantage of the internet from when they are online to entering cyberspace.

The use of cyber by children has brought about fundamental social changes in people's lives that greatly affect children's values and behavior. Deviations in behavior or unlawful acts committed by children, among other things, are caused by factors outside the child's self. The phenomenon of cyber crime, ranging from defamation, exploitation crimes, pornography and so on, children in Indonesia have the right to be protected from the crimes mentioned above. The need to formulate a criminal law policy as an effort to buy protection from the development of the use of cyber media, requires a very in-depth study, concerning philosophical, juridical, sociological aspects and so on. Information technology is now very strategic and has a broad impact on human life activities, therefore special arrangements are needed by the establishment of a law that can deal with crimes against information technology.

So it can be said that the existence of the Internet or this new media has changed the pattern of human communication. Preferable to use social media following applicable regulations and subject to the Law of the Republic of Indonesia Number 19 of 2016 concerning Amendments to Law of the Republic of Indonesia Number 11 of 2008 concerning Electronic Information and Transactions. As well as the need for an active role from the community and parents in supervising children in using social media so that they are not entangled with criminal sanctions and/or compensation.¹⁵

Media literacy skills, especially social media, must be introduced to children from children if they do not want to be left behind and become strangers in an environment that has been exposed to digital information flows. It is hoped that media literacy for children regarding the use of internet media can reduce the bad effects of using this media and also information that cannot be denied spreads to negative things such as: consumerism, a culture of violence, a culture of peeking at people's privacy,

The process of searching for information / information literacy on the internet and social media within the Banyumanik Village PKK activist environment is not yet systematic. This is evident from the steps taken to search for information that have not been able to formulate problems or information needs, have not been able to choose the right search strategy, have not been able to determine the location and method of accessing information correctly, some have not been able to maximize, synthesize and evaluate the information obtained.; Optimization through social media has not been maximized, as seen from the utilization and only normal friendships. Then it can be categorized / classified as a passive search.
