Competence is closely related to authority, a competent person is one who has the ability and at the same time the authority. For this reason, the commitment and competence of librarians are needed to meet the expectations of the librarian community. There are two types of competencies:

- a. Functional competence is knowledge of information sources, technology,
- b. management, research used to provide services.
- c. Personal competence is the skills, behaviors that librarians have in order to work effectively as communicators, improve their abilities and be able to survive the changing and developing times.
- d. In simple terms, librarians should perform their main role, and not just do it right but especially do the right thing in answering every changing event. Unfortunately,

until librarian now the competency standards in Indonesia are still in the process of being compiled so that there are no clear guidelines that are used as reference a librarian competencies such as size, system, rules of the game, competency test materials and competency tests.

Information literacy according to the American Library Association (ALA) (2000) is a set of individual abilities to recognize information when needed and have the ability to find. evaluate. and use information effectively. Information is available in various forms such as print vs electronic, in various places such as libraries, organizations, media and the internet, and is used for various academic, work and daily life purposes.

A society that has information literacy is a society that understood, realized, comprehended and used writing (reading information sources). In other words, in addition to having an oral culture that has been carried from generation generation, hundreds or even thousands of years. They have developed a reading and writing culture (Sutarno NS. 2006). Communities that have a high reading culture must continue to be balanced with the provision of facilities such as libraries and adequate reading materials according to community needs (Priyanto, 2007).
