# The Role of Bhabhinkamtibmas in Combating Crimes Committed by Youth Through Coffee Farming Empowerment (Case Study of Girimulyo Kulon Progo Research)

Abstract. This study aims to determine and analyze the role of Bhabinkamtibmas in the context of overcoming criminal acts committed by young people through empowering coffee farming in the Purwosari area, Kapanewon Girimulyo Kulon Progo in order to prevent criminal acts, and the obstacles encountered by Bhabinkamtibmas in the context of overcoming criminal acts committed by young people through empowering coffee farming, as well as solutions in anticipating the obstacles encountered. This research approach is carried out using sociological juridical, namely identifying and conceptualizing law as a real and functional social institution in a real life system, after primary and secondary data are obtained, a qualitative analysis is carried out, namely a material analysis method by describing the data obtained in the form of detailed and clear sentences, using deductive and inductive thinking methods. The results of the study can be concluded that the role of Bhabinkamtibmas in the context of overcoming criminal acts committed by young people through empowering Coffee Farming is carried out in two ways, namely first identifying the background of the problem related to the importance of carrying out agricultural empowerment, Second implementing the results of the identification that has been formulated by preventing criminal acts through a social approach, the lack of employment opportunities and skills possessed by young people, carrying out mentoring efforts to encourage becoming entrepreneurs who are closer to the digital market and becoming a facilitator with competent stakeholders. Obstacles encountered are lack of technical knowledge, lack of resources and facilities, lack of community participation, weather and environmental constraints, climate change, pests, and plant diseases that can affect crop yields, coordination with related agencies, and the private sector. budget limitations. Solutions in overcoming obstacles in changing mindsets by showing that coffee farming can be a profitable business holding interesting training and workshops, such as barista techniques, coffee roasting, and digital marketing, by promoting the success stories of young coffee farmers as inspiration, Encouraging business capital assistance programs or people's business credit (KUR) specifically for young farmers. Proposing a land rental program from senior farmers to young people to start farming, Encouraging cooperation between young people in the form of cooperatives or agribusiness

communities, Holding coffee cultivation training from upstream to downstream by involving agricultural experts and coffee industry players, providing internship programs on coffee plantations or coffee processing industries.

#### 1. Introduction

In the development of social life, individual interactions occur, which gives rise to mutual need. There are even some individuals who are not really getting what they want in life, so they do anything to get it, one of which is by actions that harm others. This action in the development of crime is called criminality. Criminal acts in general can involve all elements of society, especially this action is vulnerable to groups that are clearly pressured to get their desires or needs. Even in social development, young people have the potential to be involved in criminal acts in social life. Criminal acts involving young people are driven by psychological factors and the environment which ultimately impacts young people being unable to control their emotions.

The state, in this case Indonesia, certainly does not want its young generation to be emotionally unstable and unable to control their emotions. This will undoubtedly impact the nation's regeneration, as young people in Indonesia are unable to control their emotions, thus impacting society in general. Unstable emotions will undoubtedly cause chaos in society, leading to criminal acts. Therefore, the state must be present to address these issues.

Preventive measures must be implemented through education and mentoring for the younger generation. Furthermore, a consistent law enforcement system must be in place, enabling the community to participate in protecting young people. Law enforcement officers must also engage with the community to ensure children remain supervised in their social interactions.

The implementation of this approach to society is part of an effort to prevent wider criminal acts, due to the actions of young people, so as a country of law in the legal system in the constitution of the Republic of Indonesia has applicable legal rules, this is indicated by the legal basis, namely in Article 1 paragraph (3) of the 1945 Constitution of the Republic of Indonesia which states that "The State of Indonesia is a state of law". This shows that Indonesia as a country has prepared all the means to resolve legal problems that arise in society. According to Firman Nur Kholid, Francisca Romana Harjiyatni and Sri Handayani Retna Wardani in their research, it states that In a state based on the rule of law, every action or authority of the ruler must be in accordance with applicable statutory regulations,

although in reality, the process of enforcing the law cannot proceed independently. Therefore, implementing regulations that remain based on the law are necessary.<sup>1</sup>

Based on this, legal regulations in law enforcement efforts must be implemented so that they can impact the existing legal enforcement system. Law enforcement, particularly regarding youth crime, must be implemented with preemptive, preventive, and repressive measures. These three measures must be implemented in a measured manner and tailored to the consequences of the crime.

In the prevention process or so-called preemptive is an effort to implement with an approach or appeal which is certainly done to provide understanding to young people to carry out actions that are close to criminal acts, especially those actions that result in harm to others in general. This action is carried out by law enforcement, one of which is the Police In the existing law enforcement system in society, the role of the Police is very important, because, the state is present by forming a state apparatus, namely the Police to prevent criminal acts and create order and security in society. According to Yustinus Bowo Dwinugroho, Lilik Mulyadi, and Suryawan Raharja, explaining regarding the formation of the Police institution, it states that the Republic of Indonesia Police is an executive institution that moves at the forefront in handling legal cases. The role of the Police as the forefront in law enforcement is important and become a parameter for the movement of the law, whether it will be better or whether its actions will be in the hands of the front line, the police. Responding directly to criminal acts in the community is the responsibility and authority of the police.

Efforts to respond to the police's responsibility and authority in enforcing crime are carried out by the Police through Article 2 of Law Number 2 of 2002 concerning the Police, which explains that "The function of the police is one of the functions of the state government in the field of maintaining public security and order, law enforcement, protection, patronage, and service to the community." Based on this, the Police's duties are important. According to Dewi Sartika, Rina Khairani Pancaningrum, Joko Jumadi, they explain that:

To carry out these duties, the police station one police officer in each village under the command of the Directorate of Community Development, or BINMAS for short, namely Bhabinkamtibas Personnel. Bhabinkamtibas functions as a community development officer who coordinates directly with the Village Head or Lurah and actively provides assistance in social activities in the community where they are assigned. The capacity and capabilities of Bhabinkamtibmas in the development process.<sup>3</sup>

Based on this, the implementation of optimizing the performance of the Police in approaching the community is carried out by Bhabhinkamtibmas, as the front guard, this can be seen from the efforts to prevent criminal acts in community life, especially to carry out prevention.

This implementation does not regardless of what was done by the Kapanewon Girimulyo Police, Kulon Progo Regency in Village Purwosari in do prevention action crimes that potentially involve young people. The implementation of the approach is carried out by empowering young people through coffee farming. The implementation empowerment Coffee This done for empowering the economy, especially young people who are economically disadvantaged after graduating from school, lack employment. On the other hand, with many young people leaving their hometowns, the village economy is stunted, leading to young people remaining in Purwosari Village resorting to crime to meet their living needs. The implementation of youth empowerment has proven beneficial during the COVID-19 pandemic that hit Indonesia. Many young people have left their hometowns. This is due to the large number of layoffs and restricted mobility that have prevented people from seeking employment. Young people living away from home often find themselves confused about what to do to find work. Being unemployed automatically means the resources they acquired during their time away from home will be depleted, leading to criminal acts that will undoubtedly lead to instability and security insecurity public order in the Purwosari Village area. The development of coffee farming empowerment certainly has an impact on young people who return from work to find a search meta.

in their homes, so that during the Covid-19 pandemic, the implementation of optimizing young people to be empowered in carrying out productivity through coffee farming becomes an alternative to maintain the economy. On the other hand, it also provides business opportunities for the younger generation to maintain and innovate in coffee farming, as well as encouraging these young people to do more positive things to develop themselves, especially in their residential areas. This implementation is positive and new hope in efforts to empower young people to be creative and far from criminal acts through police duties carried out by Bhabhinkamtibmas, at least the presence of the police becomes protective and ready to provide community assistance in economic empowerment, especially young people to prevent crime in the Kapanewon Girimulyo Police Area, Kulon Progo Regency in Purwosari Village.

Based on this, the research conducted focuses on the implementation of the role of Bhabhinkamtibmas in the Purwosari Village Area, Kapanewon Girimulyo Police, Kulon Progo Regency in providing mentoring to young people to see the potential of the region through coffee farming, so that existing economic development can prosper the community and open up job opportunities for the surrounding community, especially young people. On the other hand, young people who have graduated from school and have to work can be channeled to immediately get a job, or at least have the skills to manage coffee so that the younger generation who in the Purwosari Village area, the Girimulyo Sub-district Police, Kulon Progo Regency, have hopes for the future by leaving behind criminal acts that can lead to a misdirection in their future.

#### 2. Research Methods

The type of research is descriptive analytical from existing words, writings and documentation related to the role of Bahabhinkamtibas in empowering young people in the field of coffee farming in order to reduce the crime rate involving young people in the Purwosari Village, Girimulyo Subdistrict, Kulon Progo Regency.

Judging from the location, this research is a case study research, namely the handling of preemptive and preventive law enforcement carried out by the police in the Kulon Progo Police jurisdiction.

#### 3. Results and Discussion

# 3.1. The Role of Bhabinkamtibmas in Combating Criminal Acts Committed by Youth through Empowerment of Coffee Farming

The implementation of law enforcement carried out by the Police is actually carried out by mapping criminal vulnerabilities as an effort to determine the actions that will be taken by the Police and determine the methods that will be used, so that these anticipatory efforts can be suppressed as much as possible so as not to become a public security problem. Other tasks are carried out by making persuasive efforts, this is part of the duties and responsibilities of the Police so that the public knows that the actions taken by the Police are indeed carried out first, so that the public is not surprised if there are more decisive actions.

This more assertive action is part of the National Police's efforts to maintain public order and security. On the other hand, assertive action is part of the National Police's actions protected by law, as stipulated in Law Number 2 of 2002 concerning the Police. This regulation directly regulates the National Police's authority to enforce the law. On the other hand, action is taken as a result of community actions that clearly violate statutory regulations, or This action is considered to be an action that threatens public security and order.

In an effort to enforce the law persuasively or more in the midst of community life, the Indonesian National Police through the Community Development Unit, carries out duties in every village or more and these actions are commanded directly by the Chief of the Sector Police. These actions are regulated in Article 15 paragraph (1) of the Chief of the Republic of Indonesia National Police Number 7 of 2021 concerning Bhayangkara Fostering Public Security and Order, which explains "Bhabinkamtibmas who have been appointed as referred to in Article 11, carry out duties in villages/sub-districts with 1 (one) village/sub-district 1 (one) Bhabinkamtibmas". Based on this, the Bhabinkamtibmas' actions become a matter of carrying out persuasive actions in every village which is important to create public security and order. On the other hand, it has a role to detect criminal acts that arise around the community.

The presence of Bhabinkamtibmas (community police officers) within the community, particularly in villages and sub-districts, is crucial because it demonstrates the National Police's capable personnel in maintaining public security through these measures. These

measures also require special attention from the public, ensuring that any activities that involve large crowds must at least coordinate with the Sector Police to ensure security from local personnel.

The implementation of the placement of Bhabinkamtimbas personnel as personnel who are indeed the spearhead in the community is carried out in the Purwosari Village area, Girimulyo District, Kulonprogo. Purwosari Village as one of the Villages in Girimulyo District, Kulonprogo Regency, which is located on Menorah Hill. This hill is located on the west side of the border of DIY and Central Java, this hill stretches from Magelang Regency to Purworejo Regency, and one of the hill areas is included in the DIY Region, namely Girimulyo District. Girimulyo District has 4 (four) Villages, or Villages, namely Purwosari, Jatimulyo, Giripurwo and Pendoworejo. Based on these four villages, there are 4 (four) Bhabinkamtibmas personnel assigned to each person in Purwosari, Jatimulyo, Giripurwo and Pendoworejo Villages.

Bhabinkamtibmas personnel at the Girimulyo Police Station generally have the same duties and authorities as personnel in other sector areas, but as an effort to prevent criminal or criminal acts that result in criminal penalties for the perpetrators, there is something interesting that is done by Bhabinkamtibmas at the Girimulyo Police Station who has duties in Purwosari Village, namely providing assistance to the community regarding the empowerment of coffee farming. This action was carried out during the Covid-19 pandemic at that time, people who had been able to freely carry out activities outside the home, even most of the people from Purwosari Village were looking for work outside Kulonprogo, so the potential for great the number of people returning to their hometowns is increasing, potentially impacting the potential for unemployment. On the other hand, with existing unemployment, when finding work is difficult during the COVID-19 pandemic, young people returning to their hometowns may resort to crime, thus negatively impacting social life. Kanist explained this as follows:

Covid-19 This impacts the potential of young people, stifling them. On the other hand, young people working outside Kulonprogo are likely to return to their hometowns, leading to unemployment. When these workers are unemployed, they will likely engage in criminal activity, which will negatively impact public safety and order.<sup>4</sup>

This condition shows the need to look at the pattern of approach to the community that can strive for a more persuasive approach but still these young people take actions that can develop their economic conditions when Covid-19 hit, then seeing the potential of the region and seeing the importance of the generation of coffee farmers being raised through young people, then with this sustainable pattern, Bhabinkamtibmas Kalurahan Purwosari innovated the community to carry out sustainable coffee empowerment as a regional potential and a potential that must be carried out according to geographical conditions. This potential is seen as important to suppress crime and provide business opportunities for children young people in Purwosari Village to innovate in improving the economy through coffee farming.

The implementation process of this agriculture must certainly be seen from the potential for crime during the Covid period, as well as the efforts of the Bhabinkamtibmas in empowering coffee farming as a community police role, as well as the role of the community to advance agriculture which is seen from the community's enthusiasm and the implementation of this empowerment can be sustainable so that it becomes a livelihood in Purwosari Village and a new identity for Purwosari as a coffee producer in the Kulonprogo area.

#### 1. Public Security and Order Situation

The Covid condition emphasizes the public to stay at home so that the spread of the virus does not become an epidemic, so that any steps taken by the government by prohibiting activities outside the home, so that the impact is that the actions taken by the government force companies to unilaterally terminate employment, this is certainly felt by young people who migrate outside Kulonprogo to work so that these actions have an impact on the emergence of unemployment and the existence of criminal acts, especially related to criminal acts that occurred in the Girimulyo Police Area when Covid-19 occurred in Indonesia, the data can be seen as follows:

The data above does indeed show that the crime that occurred in the Girimulyo Police Sector area is not worrying, however, crime has increased, especially at the beginning of the year when Covid-19 started to enter Indonesia. In 2020 there was a significant increase, namely the existence of

Three crimes were reported. One of the reported crimes was related to theft, and the other was assault. Based on data showing that COVID-19 could potentially impact criminal issues such as theft, law enforcement is still being carried out properly, in accordance with applicable legal procedures. Therefore, regarding the crime data, the Girimulyo Police Chief stated:

In general, the public order and security situation in the Girimulyo Police area is safe and conducive, with several minor criminal incidents occurring. The majority of crimes occurring in the Girimulyo Police area are minor crimes, such as domestic theft and livestock theft. The impact of these crimes is the legal process.

If it is carried out but there are legal steps with the application of restorative justice, then the resolution can only be carried out at the Polsek level.<sup>5</sup>

The existence of criminal acts that occurred in the Girimulyo Police Sector Area is something that is considered an incident that is said to be part of a minor crime, however, the action was carried out directly involving residents in Girimulyo, meaning that there is an important thing for the Police to be aware of this situation, because if this condition is left alone it will certainly have an impact on long-term social problems and not break the chain of crime in the Girimulyo Area. On the other hand, the Girimulyo Area as an area at the foot of Menoreh Hill is certainly not as dense as in the lowland areas so that the potential for crime is not so frequent because the population density is not dense and the community is small with the geographical potential of the slopes, of course committing crimes at night must be rethought, because they do not know the terrain if they are not local residents.

The general social conditions that exist are that young people in the Purwosari area do not have special skills, so the potential activities they carry out are hanging out, so that with these activities they have the potential to carry out useful activities or at least those that can produce productivity in everyday life, because these actions if allowed to potentially commit crimes. On the other hand, with In carrying out the act of hanging out, these young people certainly need money, so if there is no economic income, the shortcut is to commit crimes, this was expressed by a Community Leader as follows:

The activities of young people who do not have jobs are done by hanging out, of course they also need living expenses for daily needs to buy cigarettes, even alcohol and other pleasure needs, of course this causes unrest for the environment because finally they look for shortcuts to quickly get money to meet their daily needs, they even force their parents to get money and even take their parents' valuables to sell without the knowledge and permission of their parents.<sup>6</sup>

Seeing the existing social conditions, with the activities of young people who only engage in unproductive gatherings and require funding to meet the needs of life, efforts are made through economic empowerment methods by involving existing workforces in order to utilize existing local potential, so that reducing crime will be seen, because young people if left alone will have the potential to carry out actions that can harm the environment, such as committing crimes such as theft, fighting and even drug abuse, so that it will have a real impact on young people and the environment becoming unsafe and uneasy.

#### 2. The Role of Bhabinkamtibmas as Community Police

The Bhabinkamtibmas, as the vanguard in law enforcement, is of utmost importance. This is not without reason, as the Bhabinkamtibmas function is one of the National Police's duties in carrying out community policing. This is stipulated in Indonesian National Police Regulation Number 1 of 2021 concerning Community Policing. Therefore, the Bhabinkamtibmas's steps in the Girimuloyo Police Sector are as follows:

# a. Conducting community visits

In order to carry out the prevention of potential criminal actsoccurred in the Girimulyo Police Sector Area, the efforts implemented by the Girimulyo Bhabinkamtibmas were carried out by maximizing preemptive activities, namely by visiting residents' homes door to door, carrying out guidance and counseling to community groups such as youth groups, farmer groups, PKK mothers' groups conveying public order messages to all levels of society so that residents obey the law, avoid being victims of crime or perpetrators of crime carried out by the Binmas unit or by Bhabinkamtibmas whose duties are directly in the midst of the community. This implementation was expressed by the Head of Bhabinkamtibmas as follows:

Bhabinkamtibmas carries out efforts to prevent crime by carrying out preemptive activities by visiting residents' homes door to door to deliver messages public order and security messages and carry out detection to gather information related to the security and order situation and conditions in the environment, ask whether there are any problems in the environment, then the Bhabinkamtibmas looks for appropriate solutions according to the problems that are occurring, both short-term solutions and long-term solutions.<sup>7</sup>

This action was responded to very positively by the community and was very well received because with the persuasive approach, the community was provided with education and understanding and the community was more easily accepted the message conveyed. The hope is to encourage the community to build their awareness, create a good, more harmonious relationship between the police and the community and increase voluntary participation because the community tends to be more motivated to participate if the community already understands the benefits and feels that the decision comes from themselves because the community is given space to think and make their own decisions without feeling forced.

b. Bhabinkamtibmas becomes a mediator in disputes over minor crimes.

Criminal acts caused by minor problems or disputes can potentially lead to prolonged disputes in the community, so as not to cause disturbances to security and comfort, the main steps taken by the Police are related to every criminal act that occurs in the community and that can be resolved amicably, then it can be carried out amicably, so that legal steps as repressive measures are taken as much as possible to avoid this, as stated by the Girimulyo Police Chief as follows:

Girimulyo Police encourages the Bhabinkamtibmas for every minor crime that occurs if each party wishes to resolve it amicably, so that the Bhabinkamtibmas provides the widest possible space to be facilitated through mediation involving the FKPM and community leaders, then a joint deliberation is held to find a common ground for resolving the problem, then the points of agreement are stated in a joint agreement letter that the problem has been resolved amicably, and there is no mutual legal action.<sup>8</sup>

Disputes within the community often arise from disturbing community activities, necessitating such measures. On the other hand, friction arises from actions that are actually caused by friction during entertainment or community activities that create crowds. Therefore, efforts encouraged by the Police in response to these incidents include mediation. The goal is to prevent existing disputes from impacting public safety and order in general, as there is concern that these actions will lead to acts of revenge by certain irresponsible parties, resulting in the general public, unaware of the root of the problem, becoming victims.

Furthermore, this anticipation can at least be read by the police who are aware of the potential for further criminal acts to occur.

c. Bhabinkamtibmas carries out early detection of potential criminal acts.

Carrying out innovation and early detection related to criminal acts should be carried out optimally, this is not without reason because Bhabinkamtibmas who have the duty and function of being part of the community and close to community life, can map the potential for criminal acts, or find out community information related to criminal acts, so that criminal acts that will be committed can be prevented before they occur. This is an innovative step from Bhabinkamtibmas based on actions in the community, so that the next step can be informed to the criminal investigation unit if it becomes something that needs to be enforced, or other steps through preventive measures are carried out by joint operations. This idea was confirmed by the Head of Binmas as follows:

The steps taken by Bhabinkamtibmas are by conducting early detection to look for potential criminal acts that may occur, then data is collected from each of the identified problems, then an analysis is carried out, how is the response from the environment, the response from the community and from the police itself, then only the most prominent problems are evaluated which are a priority to be resolved immediately to minimize the negative impacts that occur if the problem is not resolved immediately.<sup>9</sup>

This statement demonstrates that early detection of potential criminal acts is a crucial preemptive measure for law enforcement. The goal is to minimize and anticipate potential crimes that could result in casualties in society. Furthermore, with these anticipatory measures, the National Police (Polri) has at least attempted to maintain security and order by considering all aspects of society. Therefore, law enforcement is not simply carried out through repressive measures, but through preemptive measures that must be prioritized.

The role and steps of Bhabinkamtibmas as Community Policing, emphasizes that law enforcement is not only law enforcement carried out simply by people violating the law, but legal action carried out by the Police is carried out as early as possible from the approach to the community, carrying out resolution actions within the community, so that the resolution has a meeting point. On the other hand, efforts are made to anticipate potential criminal acts that will arise to find out that actions that have the potential to become criminal are not repeated, or vulnerabilities in the social life of the community for the occurrence of

activities that have the potential to become criminal can be suppressed so that security and order are met.

society can be protected and community activities in general can be conducive, so that people can continue to carry out productive activities and social life can run as usual.

3. The role of Bhabinkamtibmas in implementing coffee farming empowerment in responding to the Covid-19 problem in 2020 to 2022, the Indonesian National Police (Polri), as part of the government, has a responsibility to play a role in preventing its transmission. Furthermore, with the COVID-19 pandemic, the Indonesian National Police, whose authority and responsibility are stipulated in Article 13 of Law Number 2 of 2002 concerning the Police, are responsible for maintaining public security and order. Therefore, during the pandemic, the Indonesian National Police's efforts also include detecting criminal acts.

Covid-19, in real terms, it not only has an impact on health, but also has an impact on economic problems, because of the rampant occurrence of layoffs (PHK), this is because in order to prevent widespread transmission, it is necessary to limit human movement, therefore the most effective effort is to limit community activities including in the world of work, so that it has an impact on reducing the livelihoods, so that many of the workforce are unemployed, this action if ignored will cause social problems such as theft or other crimes, therefore The Indonesian National Police, through the Bhabinkamtibmas (Community Police), needs to take innovative measures so that this social problem can be addressed through economic means.

To prevent criminal activity caused by the pandemic, an approach is needed, one of which is independent empowerment in a strong economic sector. Therefore, the Bhabinkamtimas (Community Officer) of the Girimulyo Police, Purwosari Village, has implemented an innovation in coffee empowerment through agriculture. This is motivated by preventing unemployed young people and those at risk of committing crimes from doing so. Based on this, the main factors in coffee empowerment in Purwosari Village can be seen as follows:

# a. High Unemployment Rate

Many young people lack jobs and the skills necessary to compete in the workforce. This situation makes them vulnerable to negative behavior, including falling into criminal activities such as theft, drug abuse, and violence. This, coupled with the risks of the pandemic, exacerbated the already negative economic situation. If left unchecked, these factors will undoubtedly lead to long-term social problems. A community leader from Purwosari expressed this:

The condition of young people before the empowerment of Bhabinkamtibmas in the Purwosari sub-district area was that many young people still did not have jobs, in fact their activities were only filled with gatherings, hanging out with each other.<sup>10</sup>

This means that with the unabsorbed unemployment rate, young people in Purwosari Village engage in less productive social activities, resulting in under-recruitment of the young workforce and the lack of specialized skills. If left unchecked, especially after COVID-19, this situation will become a social problem and exacerbate economic disparity in the Purwosari area. This economic disparity and under-recruitment will lead to criminal activity among young people.

#### b. Proactive Crime Prevention

Bhabinkamtibmas plays a role in maintaining public safety and order (Kamtibmas). One approach is to prevent crime early through economic and social empowerment. The goal is that consistent economic activity will ensure that people have at least a living income.

c. Utilization of Local Potential If the area has good coffee farming potential, then encouraging youth to participate in coffee farming can be a sustainable economic solution. Besides creating jobs, this also helps improve community well-being. This means that the Purwosari area has the potential to be empowered through coffee farming, so that with this potential, at least there is an effort by the community to actively participate in utilizing this economic opportunity.

The background to this potential reading is a separate reading by the Bhabinkamtibmas of Purwosari Village, this is because by making efforts to provide local assistance, at least the Bhabinkamtibmas will be more consistent in carrying out their role, this was expressed by the Head of the Binmas Unit as follows:

In the effort to implement coffee farming empowerment, location reading is important, because the Purwosari area has a geographical location on the slopes of Menorah Hill which has the potential for coffee farming, so there needs to be improvement and assistance not only in the agricultural process, if necessary through assistance efforts through production steps to marketing.<sup>11</sup>

The role of Bhabinkamtibmas in the context of overcoming criminal acts committed by young people through empowering coffee farming is part of a very strategic action, because with these empowerment efforts, it is possible to anticipate criminal acts that directly involve Young people. Here are some strategic roles played by Bhabinkamtibmas to prevent crimes involving young people through economic empowerment efforts, particularly for the younger generation, through coffee farming:

# a. Prevention Through Social Approach

Providing education to young people about the dangers of crime, such as drug use, brawls, and other crimes. Based on this, efforts to build good relationships with community leaders, youth, and coffee farmers to provide understanding of the negative impacts of crime, along with efforts to synergize in developing coffee farming to leverage local potential for economic value and community welfare, through youth-led coffee farming regeneration.

# b. Assisting Economic Empowerment Programs

Encourage young people to participate in the coffee farming sector as a positive and productive alternative. Collaborate with village governments and relevant agencies to provide training in coffee cultivation, post-harvest processing, and marketing. The hope is that through these activities, young people can find a livelihood from coffee, and their own coffee production and marketing will allow local potential to gain new hope in improving community welfare.

The actions and objectives of empowerment carried out by Bhabinkamtibmas are efforts to invite young people to be involved in community-based environmental security programs so that they are more responsible for their environment, meaning that this implementation is carried out by looking at existing potential without having to see what must be done through innovations that do not exist in the environment. With this approach, Bhabinkamtibmas not only plays a role in maintaining security, but also helps create opportunities for young people to develop economically and socially, thereby reducing the risk of their involvement in criminal acts.

The hope is that the implementation of coffee farming empowerment by Bhabinkamtibmas can at least have a positive impact in reducing crime rates through the following mechanisms:

#### a. Improving Economic Welfare

There is income that can be enjoyed by the community, so by helping the community develop coffee farming, especially for Young people are increasingly earning a living, and farming, especially coffee farming, can be an alternative source of income for locals. Furthermore, the economic stability of young people and farmers will reduce the urge to commit crime, as basic needs are more easily met.

#### b. Creating Productive Activities

People busy with agricultural activities will have less time to engage in negative activities, especially young people who are known to be unemployed. This agricultural activity can at least provide positive activities in carrying out their activities, because without realizing it, productive activities are where the wheels of the economy turn. On the other hand, increased productivity also builds awareness of the importance of working hard rather than seeking shortcuts by committing crimes. According to the Head of Community Policing Unit,

Empowering coffee farming provides at least some benefits to young people, as it can provide alternative activities for youth at risk of crime, who can be directed to work in the coffee farming sector. With a clear livelihood, they are more likely to choose a positive path in their lives.<sup>12</sup>

The existence of productive activities means that young people who work together do not have meaningful activities, with efforts to empower the community's economy, at least

there is a sense of wanting to work. In addition, if there are young people who have the potential to always have problems with the law, at least when gathering and in society, if they see their friends doing positive activities such as empowering coffee farmers, it is hoped that these young people can come and get directly involved, so that the feeling of reluctance to do useless actions will be immediately abandoned.

Overall, the coffee farming empowerment carried out by Bhabinkamtibmas not only improves the economic sector but also contributes to creating a safer and more harmonious society. The goal of this process is to guide people away from committing crimes that would ultimately harm themselves and the community.

In general, this could lead to personal legal repercussions. On the other hand, this empowerment model offers a solution for preemptively enforcing the law, as it at least helps the public understand the steps they must take to improve their economy, not resorting to criminal activity but to working through coffee farming.

# 4. Community participation in coffee farming empowerment

In carrying out community empowerment, the focus of its implementation is the community as the target object, so there needs to be an assessment related to community participation, in this case the object. Regarding the agricultural empowerment carried out by Bhabinkamtibas, the participation of the Purwosari Village community can be seen as follows:

#### a. Young people's enthusiasm for coffee farming

The coffee farming empowerment program, targeting young people in Purwosari Village, was initially carried out by the Bhabinkamtibmas (Community Police Officer) by collecting data on unemployed youth. These youth are often children of coffee farmers. During this data collection, the Bhabinkamtibmas gathered the children for discussions. A youth representative shared the following:

Initially, the Bhabinkamtimas personally gathered young people in Purwosari Village to discuss agriculture and illustrate the potential of coffee farming. They also explained that the empowerment and continued existence of coffee farming in the Purwosari area must be continued by young people. The goal was to further enhance Purwosari's reputation as a coffee-producing village.<sup>13</sup>

The discussion, led by the Community Police Officer (Bhabinkamtibmas), addressed the idea of a coffee plant empowerment program, which has been suboptimal and neglected. Therefore, there needs to be a presence for youth to continue it. From there, the Community Police Officer (Bhabinkamtibmas) implemented the empowerment program plan. The youth approved the plan, and the Community Police Officer (Bhabinkamtibmas) then scheduled a training session.

The training covered coffee plant optimization, from cultivation techniques and stem cuttings to care and fertilization, harvesting, post-harvest processing, and the processing of coffee beans into ready-to-brew ground coffee. The training was conducted by the Community Police (Bhabinkamtibmas) in collaboration with relevant stakeholders, particularly the Department of Agriculture, and provided assistance throughout the entire program.

b. No longer were young people found engaging in group activities.

The existence of coffee farming activities involving young people, with the empowerment of coffee farming for young people which has proven successful in providing many changes to social problems, for now there are no more young people who just hang out without any benefits, all of them have joined the Coffee Farmers Youth Group, namely Muda Tumpangsari with various positive activities. This was expressed by community leaders as follows:

Empowering coffee farming by involving young people has become a valuable value for young people, this can be seen in the many young people who have joined the Tumpangsari Young Coffee Farmers Youth Group, so that we no longer find unemployed young people who just sit around hanging out, which results in committing crimes.<sup>14</sup>

This phenomenon is worth being grateful for, because the condition of young people who have not been touched by the empowerment of coffee farmers, initially the youth did not have skills, but with the empowerment of agriculture, many young people can continue the tradition of coffee farming in the Purwosari area. This attitude needs to be a shared lesson so that the implementation of Coffee farming as local wisdom is not abandoned by the younger generation, because without coffee and the youth do not want to learn, then the action that will happen to our youth is unemployment and the consequences of unemployment are there is an accumulation of labor and ultimately young people look for shortcuts to commit crimes.

The role of Bhabinkamtibmas in crime prevention aligns with government programs to reduce unemployment, increase food security, and develop an agriculture-based creative economy. Furthermore, this effort supports police policies on community policing. Through this empowerment program, it is hoped that young people will be more productive, have a better future, and avoid criminal acts that harm themselves and their surrounding communities. Therefore, coordination in providing mentoring with relevant agencies, such as the Department of Agriculture, is necessary to ensure that appropriate mentoring can be implemented to support the welfare of young farmers.

This assistance is also in line with the main duties of Bhabinkamtibmas, namely maintaining public security and order (Harkamtibmas), early detection, and problem solving at the village or sub-district level, part of this assistance effort to realize public order. The Basis of Bhabinkamtibmas' Authority in Empowering Coffee Farming. Regulation of the Chief of Police Number 1 of 2021 concerning Community Policing mandates that the police,

including Bhabinkamtibmas, must play a role in community empowerment to improve welfare and reduce factors causing crime, This allows the Indonesian National Police (Polri) to create security and realize a social life that reflects the second principle, "Just and Civilized Humanity." This means that when problems arise, the community must engage in meaningful activities without disrupting social life.

# 3.2. Obstacles and Solutions to the Role of Bhabinkamtibmas in Combating Criminal Acts Committed by Young People through Empowerment of Coffee Farming

The implementation of empowerment as part of the criminal law enforcement carried out by the Bhabinkamtibmas Polsesk Girimulyo in the Purwosari Village area, certainly receives special attention because the role of the Police in efforts to accompany in resolving economic problems is a matter of concern. This is part of an effort to break the chain of crime that is increasingly rampant, especially since existing crimes are driven by people committing these crimes because of economic shortages, filling unproductive time so that they carry out actions that lead to criminal acts. This phenomenon also appears to occur in the Purwosari Village area where the majority of young people do not have skills and when they do not have skills, the actions taken are carrying out useless gatherings, so that in the end these young people commit crimes that end up harming the community, so This empowerment is crucial for young people, providing them with skills development support and income. In carrying out the empowerment program, Bhabinkamtibmas (community police officers)

It turns out that in the implementation there were obstacles, and that would certainly be an obstacle in carrying out the empowerment. Obstacles in every program implementation are indeed found, because it is impossible for every agenda that is carried out to run successfully without obstacles, especially related to the empowerment agenda which can certainly be a significant obstacle for Bhabinkamtibmas in Purwosari by changing the habits of young people and changing their mentality so that they want to produce coffee. Obstacles encountered in the implementation of coffee farming empowerment by Bhabinkamtibmas in Purwosari Village include:

# 1. Lack of Technical Knowledge

The ideas presented by Bhabinkamtibmas to young people were initially distrusted by the community. This can certainly be seen when a police officer, who is visibly known by the community as a law enforcement and security officer, unites with the community to hold a coffee empowerment, of course the community or young people do not immediately believe the ideas and concepts, because they could stop midway. This was expressed by one of the community leaders as follows:

When the Bhabinkamtibmas first started to empower coffee plants, many people did not believe that it would be successful. Of course, this was a challenge for the Bhabinkamtibmas

to convince young people by approaching them through door-to-door visits to provide motivation and messages of public order.<sup>15</sup>

This statement is not without reason, because the Bhabinkamtibmas in Purwosari Village are not agricultural experts and are not residents of Purwosari, so that directly or the existing culture, especially agriculture, does not really understand the existing conditions, so that in this implementation effort there are still many who are not sure, therefore in implementing activities, it is necessary to have assistance from agricultural extension workers or related agencies.

#### 2. Lack of Resources and Facilities

In implementing the empowerment program directly, the Purwosari Bhabinkamtibmas encountered a shortage of equipment. This was because the empowerment efforts and ideas began with the Bhabinkamtibmas' own ideas, leaving the general public unclear about the direction of the coffee farming empowerment assistance program. Furthermore, the target group was young people, so older people felt it was impossible for the Bhabinkamtibmas to carry out the activities.

The Bhabinkamtibmas experienced limitations such as limited equipment, seeds, fertilizer, and modern agricultural technology needed to increase yields. Therefore, with these limitations, the steps taken were of course communicating with the Purwosari Village so that this program could be noticed and facilitated through local government institutions. On the other hand, with support from the local government, especially the Purwosari Village, it is important to maintain the commitment between young people and parents to improve coffee farming in the Purwosari area.

# 3. Lack of Community Participation

At the beginning of the coffee farming empowerment program for young people, many people, especially older people who were already coffee farmers, were skeptical. This was not without reason, as the target group was young people who generally only had unproductive activities and no desire to farm. On the other hand, many young people worked outside the city, creating a gap in the young farming generation. This was expressed by the Head of Community Guidance Unit as follows:

In carrying out the youth empowerment program for coffee farming, some farmers may not believe in the program initiated by the police or lack the motivation to change, because many young people are involved in unproductive activities, especially since many young people prefer to look for work in the city so that local coffee products are only used by young farmers.<sup>16</sup>

Based on the farmers' lack of confidence, they have a clear reason because young people today and in the region do not have the skills and mindset that in general cannot be

encouraged to progress, so if it is just ignored it will become a social problem, especially since the theft that occurs only occurs within the family, meaning there needs to be a persuasive approach to introduce coffee farming as an ancestral heritage, which must be preserved and maintained as a livelihood for the local population and to sustain coffee production from Purwosari.

In the face of coffee farming empowerment policies and the obstacles mentioned above, the empowerment program must continue. The goal is to ensure that communities, especially young people, can continue to generate income, and these obstacles must be addressed. The goal is to ensure that this agricultural empowerment program doesn't stall midway without a sustainable program. Therefore, actions to address obstacles in implementing coffee farming empowerment for young people include:

1. Changing mindsets by showing that coffee farming can be a profitable business.

In implementing the coffee farming empowerment program, which does not only focus on agricultural products, but rather strives to improve the economy through the coffee farming production process, it is necessary to change the mindset by innovating by holding interesting training and workshops, such as barista techniques, coffee roasting, and digital marketing, as well as by promoting The success story of young coffee farmers as inspiration, so that it can become the enthusiasm of young people in Purwosari to farm coffee.

2. Promote business capital assistance programs or people's business credit (KUR) specifically for young farmers.

The implementation of capital assistance also needs to be publicized through collaboration with state-owned banks, so that young people can develop alternative ideas for running coffee farms. Furthermore, such outreach can have an impact by providing young people with access to KUR (People's Business Credit) applications to advance coffee farming.

3. Proposing a land rental program from senior farmers to young people to start farming.

In order for empowerment to continue, support is also needed from senior farmers who own land, or who have already worked the land. Therefore, Bhabinkamtibmas facilitates senior farmers to rent out half of their cultivated or currently cultivated land to young people. This action is expected to provide young people with experience in farming even if they do not have land. In addition, the implementation of land issues is also communicated with the Village Government so that the Village Government can facilitate the rental of land owned by Purwosari Village or unmanaged land to be rented to young people with a profit-sharing system, thus providing income from the village's original income.

4. together among young people in the form of cooperatives or agribusiness communities. Implementation of sustainable empowerment means a community that supports each other is needed, in capital, or even equipment and seeds, therefore it is necessary to make efforts to form cooperatives or agribusiness communities even though the existence of young farmer groups has been formed but to obtain capital they can help each other, then the efforts to form cooperatives will be felt together because with this system at least the farmers can help each other in the field of capital.

The cooperative can also facilitate coffee sales, allowing farmers to produce coffee, all managed by the cooperative. Furthermore, marketing management will be streamlined, as the cooperative can also handle marketing, thereby creating jobs not only as farmers but also as marketers. This will allow the residents of Purwosari Village to prosper thanks to coffee farming. Coffee farming is expected to be more than just a cultivation activity, but also a defining characteristic of Purwosari's coffee industry.

#### 4. Conclusion

Based on the discussion in the analysis of the previous chapter, the following conclusions can be drawn from this research: 1. The role of Bhabinkamtibmas in the context of overcoming criminal acts committed by Young People through the empowerment of Coffee Farming is carried out in two ways, namely first identifying the background of the problem related to the importance of carrying out agricultural empowerment, this is done due to the high level of unemployment in the Purwosari Village, Girimulyo District, Kulonprogo, especially during covid-19, preventing criminal acts because with many unemployed the potential for crime increases, in addition to local potential that is suitable for implementing coffee empowerment. Secondly, implementing the results of the identification that has been formulated by preventing criminal acts through a social approach, helping to empower the community's economy due to the lack of employment and skills possessed by young people, and making mentoring efforts to encourage them to become entrepreneurs who are closer to the digital market and becoming a facilitator with competent stakeholders, so that the implementation of this empowerment can be sustainable and improve the standard of living of the community. 2. Obstacles and Solutions to the Role of Bhabinkamtibmas in the Framework of Overcoming Criminal Acts Committed by Young People through Empowerment of Coffee Farming, can be described as follows: a. Obstacles encountered in implementing coffee farming empowerment by Bhabinkamtibmas include: 1) Lack of Technical Knowledge, because in the implementation of agricultural empowerment, Bhabinkamtibmas only acts as a facilitator and Bhabinkamtibmas is not an agricultural expert, so it is necessary to collaborate with agricultural extension workers or related agencies. 2) Lack of Resources and Facilities, this can be seen from the limited tools, seeds, fertilizers, and modern agricultural technology to increase crop yields. 3) Lack of Community Participation, the empowerment program initially met with pessimism from senior farmers, because this empowerment step was not carried out by the farmers themselves or related agencies, but was initiated by the police or lacked motivation to change. 4) Weather and environmental constraints, climate change, pests and plant diseases can affect harvest yields, which are sometimes not optimal from the start of production to the results. 5) Limited Market Access. This is crucial, as after harvest, farmers may have difficulty selling their coffee at a reasonable price profitable due to lack of access to markets or long distribution chains. 6) Coordination with Relevant Agencies. Empowerment programs often require synergy with agricultural agencies, cooperatives, and the private sector, which can be challenging without effective communication, collaboration, or even mentoring from relevant agencies. 7) Budgetary Constraints. Funding is crucial for conducting training, purchasing equipment, and agricultural development, and it is often limited, preventing programs from running optimally. b. Solutions to overcome obstacles in implementing coffee farming empowerment for young people include: 1) Changing mindsets by showing

that coffee farming can be a profitable business 2) Conducting engaging training and workshops, such as barista techniques, coffee roasting, and digital marketing, by promoting the success stories of young coffee farmers as inspiration. 3) Promote business capital assistance programs or people's business credit (KUR) specifically for young farmers. 4) Proposing a land rental program from senior farmers to young people to start farming. 5) Encourage cooperation between young people in the form of cooperatives or agribusiness communities. 6) Conducting coffee cultivation training from upstream to downstream by involving agricultural experts and coffee industry players. 7) Providing internship programs on coffee plantations or coffee processing industries.
